WHEREAS, our schools should be safe spaces for anyone that walks through our doors.

WHEREAS, many of our students, parents, caregivers, staff and community members identify as LGBTQ+.

WHEREAS, our strategic plan emphasizes that the well-being for all of our students and staff are met through a focus on equity and inclusion.

WHEREAS, raising the Pride flag demonstrates this commitment to our students, staff, parents, caregivers and community members.

WHEREAS, Pope Francis has told parents of LBTQ+ children that "God loves your children as they are" and "the church loves your children as they are because they are children of God."

WHEREAS, Mark 10:13-16 states "People were bringing little children to Jesus for him to place his hands on them, but the disciples rebuked them. When Jesus saw this, he was indignant. He said to them, "Let the little children come to me, and do not hinder them, for the kingdom of God belongs to such as these. Truly I tell you, anyone who will not receive the kingdom of God like a little child will never enter it." And he took the children in his arms, placed his hands on them and blessed them."

WHEREAS, we as a Board wish to ensure all the students and staff attending our schools and their families, know that we support and are welcoming of all students, staff and community members,

starting with 2021 and to work with Student Senate and Staff in organizing events throughout the month that focus on equity and inclusion for all.

BE IT FURTHER RESOLVED that each class in each HCDSB school be mandated to have a safe space poster, to ensure that students in the 2SLGBT community are supported throughout the entire school year.

Purpose

To provide Trustees with an update on the process of naming the new Milton No. 3 Catholic Secondary School as per Board Policy I-15 School Name Selection.

Background Information

In consultation with the Milton No. 3 School Name Selection Committee, which consisted of Chair Patrick Murphy, Vice Chair Marvin Duarte, Father James S. Petrie of St. Benedict Parish, Claudia Brena-Ianiro, (parent), Jennifer Santos (parent), Student Trustee, Nicholas Gubert, Superintendent Emi Bakaic and Principal Kevin Wong, four (4) names were submitted for consideration to members of the broader community.

Comments

Stakeholder Consultation – Request for Potential Names

On Wednesday, February 24, 2021, an invitation to submit potential school names was sent to the Our Lady of Fatima and Guardian Angels (Milton) school communities. The results of the feedback received is provided in <u>Appendix A</u>.

Shortlist of School Names Selected

On Wednesday, March 17, 2021, the Milton No. 3 School Name Selection Committee reconvened to review the names submitted by community members. The Committee developed a short list of names in accordance with the Diocesan criteria outlined in Policy I-15. They considered all the names and rationale provided by community members and created a shortlist of four (4) names:

- Blessed Carlo Acutis
- St. Josephine Bakhita
- St. John Bosco
- St. Kateri Tekakwitha



Stakeholder Consultation –Vote for Preferred Name(s)

A voluntary, anonymous online feedback form was made available between March 19 and March 29, 2021 (inclusive). The link to the online forms was sent via email on March 19th to all parents with children currently attending Guardian Angels Catholic Elementary School and Our Lady of Fatima Catholic Elementary School, inviting them to select their top two (2) preferences from the shortlist of potential school names. The survey was also promoted on the two school websites, as well as, through St. Benedict Parish for parishioner input.

The rationale for the name selection and a brief biography of each saint were provided and are provided in <u>Appendix B</u>. The feedback received is provided in <u>Appendix C</u>.

As illustrated in the chart and table in Appendix C, there were a total of 1075 votes among the four suggested school names.

The name 'St. Kateri Tekakwitha' had the highest number of 1^{st} choice votes (n = 445, 42%), followed by 'St. John Bosco' (373 votes, 35%), 'St. Josephine Bakhita' (132 votes, 12%), and 'Blessed Carlo Acutis (115, 11%).

The preference of the community, as outlined above, is in favour of naming the new Milton No. 3 Catholic Secondary School, 'St. Kateri Tekakwitha'.

Conclusion

In accordance with Policy I-15, Trustees are invited to consider two (2) recommended names for the new Milton No. 3 Catholic Secondary School, and subject to Board approval, forward the two (2) names to His Excellency, Bishop Douglas Crosby for consideration and response.

Alignment to Strategic Plan

This report is linked to our strategic priority of Foundational Elements: Optimizing organizational effectiveness.

Purpose

The *Education Act* requires each school Board to establish a School Year Calendar, identifying instructional days, professional activity days and holidays for each school year. The Ministry of Education establishes the number of days for the schools in the Province and in accordance with Regulation 304, each Board is required to submit a Board-approved calendar to the Ministry of Education by May 28, 2021.

Background Information

The School Year Calendar Committee takes into account several considerations:

- 1. School communities have generally advised that, when selecting a Professional Activity (PA) Day, a Friday or Monday is preferred. Some employers appear more willing to permit parents to have occasional holidays on those days (or just before statutory holidays).
- 2. An essential factor in the establishment of the 2021 2022 calendar is the integration of transportation services with our co-terminous Board. Consultation, which complies with Ministry direction, has occurred with the Halton District School Board.
- 3. The Ministry of Education has asked school boards to consider having the 3 Provincial Priority PA Days before the start of classroom instruction for the 2021-2022 academic year.

Comments

The 2021 - 2022 School Year Calendar Committee is comprised of a parent representative of the Catholic Parent Involvement Committee (CPIC), OECTA Unit Presidents (Elementary and Secondary), CUPE 3166 and 5200 representatives, the Principals' Association representatives and one (1) trustee. The Committee met on March 18, 2021 for the purpose of preparing a draft calendar.



The 2021 - 2022 School Year Calendar consists of one hundred and eighty-seven (187) instructional days, of which ten (10) days (five (5) per semester) are classified as secondary school examination days as per Regulation 304.

Two (2) PA days will be used for assessment and completion of report cards at the elementary level. An additional PA day will be used for elementary parent /teacher interviews.

The three (3) mandatory Provincial Priority PA Days that will occur next year will be devoted to criteria established by the Ministry. At the time of this report, we have not received the Provincial Priority focus from the Ministry of Education.

All seven (7) Professional Activity days align with the Halton District School Board, and both boards will have the same secondary school examination days. (*Please refer to Appendix A*).

Conclusion

The proposed 2021-2022 School Year Calendar was provided to trustees as a Staff Report at the April 6, 2021 Board Meeting and is now being presented as an Action Item. Once approved, the proposed School Year Calendar will be forwarded to the Ministry of Education for final approval.

Purpose

To obtain Board authorization to proceed with additional renewal funds required for the completion of necessary renewal components at Bishop P.F. Reding Catholic Secondary School.

Background Information

- 1. <u>Action Report Item 8.6 Proposed 2019 Facility Renewal Projects</u>, from the January 15, 2019 Regular Board Meeting.
- 2. <u>Action Report Item 8.2 Proposed 2018 Facility Renewal Projects</u>, from the January 16, 2018 Regular Board Meeting.
- 3. <u>Action Report Item 8.5 Bishop P.F. Reding Catholic Secondary School Addition Approval to</u> <u>Proceed with School Capital Planning</u>, from the March 20, 2018 Regular Board Meeting.

Comments

In March 2018, Bishop P.F. Reding Catholic Secondary School was approved for a building addition by the Ministry of Education. The approval allocated funds to add 609 pupil places to accommodate the long-term enrollment for secondary school students in Northeast Milton. The building addition was comprised of four components: a 27 classroom addition on the northwest corner of the building, a new cafeteria space on the northeast corner of the building, a new childcare centre located on the southeast corner of the building and the addition of a 4th gymnasium and exercise room. Subsequently, renewal works on the existing building were also approved to modernize the facility, such as HVAC improvements, lighting upgrades and space conversions. The renewal works and building additions are now nearing completion after nearly two years of work.

As the project has progressed, staff have identified additional funding requirements that were unforeseen at the commencement of the project. Milton Hydro has stipulated that an electrical upgrade is required to meet current design standards. Furthermore, additional temporary asphalt

installations have been required to ensure safety of staff and students on site. Lastly, additional costs associated with the Covid-19 pandemic have been realized to account for bonding, site security and rentals during the intermittent shutdowns. As such, additional funding is required to complete the project, in the amount of \$550,000 (see Appendix A). The electrical service upgrade, additional asphalt installations and the pandemic related costs would be funded through the Board's available capital funding allocations and capital reserves.

Conclusion

It is recommended that staff be authorized to proceed with the additional renewal funding allocation for the completion of required components associated with the new Bishop P.F. Reding School addition.

Purpose

The purpose of this report is to bring forward suggested revisions to the Board's Mission, Vision and Values statements.

Background Information

Under the Education Act each school board must create a multi year plan that spans a minimum of three years. The purpose of the Multi-Year Strategic Plan (MYSP) is to help Boards set long term strategic goals and priorities. The plan is evidence based and developed in a collaborative process.

Between February 11th and February 18th, 2021, Halton Catholic District School Board (HCDSB) stakeholders were asked to provide feedback on suggested changes to each of the Mission, Vision, and Values statements to help inform the next HCDSB Multi-Year Strategic Plan. Where revisions were suggested, respondents were asked to indicate a preference between the original text and the revised option. Respondents also had the opportunity to provide comments.







Figure 3. Respondents' Preference – Values Statement #1





Your identity is composed of many elements, and you can have power in some elements and be marginalized in others. By focusing on supporting and celebrating only one element of our students' identity, we are doing a disservice to all our students who may be marginalized in many other ways, some in more than one

The picture above is from "Youth Mental Health Canada", original created by Sylvia Duckworth and represents the intersectionality of these different elements of our identity. "Intersectional lens" just means not focusing on one part of identity but rather on identity as components that make up a diverse and unique individual.

If we truly want to support inclusion and equity, we need to focus on the needs of ALL our students in their diverse identities. We need support for our female & female identifying students amidst the rape culture that is prevalent today, support for our Asian students who are facing racism & discrimination and being blamed for the coronavirus, and for our Black students who as a community are dealing with the weight of police brutality and the sensationalization of Black trauma. And yes, we do need to support our LGBTQ2S+ students, but raising a flag for the whole month of June does not support these students or their diverse identities in a way that originates from, and is congruent with, our Catholic faith and identity as daughters and sons of Christ.

Our students' identities as Catholic students are important too, and by raising this flag we are sending the message to our community and the broader Halton community that students' sexual orientations and gender identities are MORE important than our Catholic identities and the teachings we follow.

Instead of raising the flag, if we want all of our students to be supported in their diverse, multifaceted identities, this conversation needs to be centred not around what we can do to support ONE component of students' identities for a month, but how we can support all students through creating an inclusive, loving, and kind community consistent with our Catholic faith.

Students and staff have come to us with their thoughts and ideas but do not feel comfortable sharing publicly for fear that their reputations would be destroyed for wanting to uphold their Catholic faith. If you have a different opinion then you are labelled as homophobic and bigoted and that is a form of bullying.

When one of our student trustees asked a question to the delegations about supporting racialized students, he was ridiculed and asked by a grown woman, "have you really ever been bullied or felt different because of your background?"

That's not okay ; how can we claim to support our students and want equity and diversity when our own students who speak up about needing support for other parts of their identities are questioned and dismissed?? And yet when the other delegate said that we cannot just go off students' anecdotes, he was accused of dismissing LGBTQ students. Double standards !!!

As a Catholic school board, we cannot ignore our identity as Catholics - so when we discuss inclusion and equity, we need to be aware of what the Catholic Church teaches and let that guide our discussion. The church does not teach us to celebrate our sexual or gender identities, but to celebrate our identity as God's children. The church does teach us to love all human beings, and that each one of us is created in the image and likeness of God and deserves dignity and respect. However, the church also teaches us that the act of sex is sacred and reserved for the sacrament of marriage, so to celebrate a component of our identity that is rooted in who we are sexually attracted to is not in line with our Catholic faith. Instead of "Pride", in which a human being puts themselves ahead of God and what he teaches, let's celebrate diverse identities including our identity as Catholics. Let's celebrate our diversity using an intersectional lens, and have these conversations about inclusion and love, while remembering that our students are not a homogenous population and yet, cannot be divided into categories based on who they are. We are all daughters and sons in Christ, and THAT is the most important element of our identity in this CATHOLIC school board.

I would like to refresh the constitutional mandate of a separate school which is to provide education in a school that the separate school board considers reflective of **Roman Catholic theology, doctrine and practices**. This mandate manifests itself in the Program of Studies and the curriculum, exercises, practises and staffing. The right to have a publicly funded separate denominational school system continues to be guaranteed to Roman Catholics in Ontario by Section 93 of the 1982 Constitution Act. The limits of this mandate are determined of the Canadian Charter of Rights and Freedoms and judicial decisions. Also the trustees are legally accountable to their electorate (composed of the members of the minority faith). If our theology is not being practiced as stated in the constitution lets make a decision to be removed from the status of "Separate Schools" and our tax dollars can be redirected elsewhere.

The pride flag does not represent "all" of the community. It would be a much better symbol to raise a 'Catholic" flag in June. For example, June is the month of the Sacred Heart of Jesus. Perhaps we can have a flag of the Sacred Heart so that it stands for the love of God as given to us in His Son Jesus who died for the love of us so that we can all hope to go to heaven by His sacrifice. We could have other Catholic flags such as one in May for Our Lady who stood by her Son at the foot of the Cross. We could raise more "Catholic Faith" awareness by the symbolism of the flag and also with service options to the students in line with the symbolism. A flag depicting our faith would embrace all the community and will not divide the community as the pride flag would.

We can also look to the Catechism of the Catholic Church for guidance on what the Catholic faith teaches on the subject of homosexual /lesbian attractions and since we are a Catholic faith community, we can and should not become promoters of a symbol that goes against Catholic teaching on the topic. (See CCC 2357-2359)

As Trustees, you have a great responsibility to God first, and then to the community, for being faithful Catholics. Children are young and impressionable and they are in school to be taught what our faith teaches. What if another student comes forward with a motion in favour of euthanasia? Or abortion? Will the pride flag open the floodgates for secularism invading our Catholic faith being lived out in the schools?

We have enough coming from the pride lobby with funding, fundamental laws being rewritten etc., and as long as we call ourselves "Catholic", lets try to be just that, "Catholic" because the word "Catholic School" becomes a misnomer.

Thank you for giving us the opportunity of expressing our thoughts we really appreciate it and we are praying that you all will make the right decision guided by the Holy Spirit.

My name is Christine McCloskey-Bruno and I attended HCDSB schools from 1987 through to 1995 at both Ascension and Notre Dame in Burlington. My own two boys attended St. Anne in Burlington for several years before I moved them to the public board in Oakville in 2018. I continue to support the Catholic board through my tax direction on my Burlington property, and feel compelled to share my thoughts on the motion that has been put forward to fly the Pride flag during the month of June at all HCDSB schools.

I watched the April 20th, 2021 Board meeting and was thrilled to see a former Notre Dame classmate, Michela Bodnar and her daughter Teia Bodnar so eloquently champion the flying of the Pride flag and the use of safe space posters in all HCDSB schools. What a breath of fresh air! I was also heartened to hear the first-hand experience of former student, Niamh Shallow, who bravely shared her personal experiences while attending an HCDSB school. It was heartbreaking to hear of her experience, one that certainly didn't speak to a climate of inclusion and support in the school setting. While Niamh was brave enough to share her personal story, we must acknowledge that there are many students in the HCDSB who are struggling in silence.

I also watched and listened to unfortunate references to "homosexual tendencies", "fornication" and the sin of "same sex marriage" and "same sex adoption", and the promotion of Courage International, a group with known links to conversion therapy, does anyone vet the content delegates are sharing?! The other thing that struck me as unfortunate was the continued discussion of treating all students "equally". I would encourage all Trustees to perhaps review the difference between equality and equity, there is a very important distinction. Equality has to do with giving everyone the exact same resources, whereas equity involves distributing resources based on the needs of the recipients.

Our 2SLGBTQ+ students need additional resources and support, this is very clear, they are telling you this, we do not require further "data" to support this need. We need to act now, especially knowing that 2SLGBTQ+ youth are especially vulnerable to mental health concerns, and face increased risk of physical and sexual exploitation, substance use and suicide. Suicide is the second leading cause of death for young people ages 10-24. LGBTQ2S youth are 14 times more at risk of suicide than straight cisgender youth. This is fact that is supported by data.

I had a long-standing belief that the Catholic Board was somehow "better than" or "superior" to the public Board. I can tell you from firsthand experience that this is not the case. Since my boys have moved to the public Board, they have attended a school that flies the Pride flag each June, is truly a safe space, and has visual reminders of this throughout the school building. They have friends from many different cultural and religious backgrounds and as a result have a deep appreciation and respect that is shaping them into strong Catholic men.

I actively encourage all of you to vote in favour of this motion. The time has come for the HCDSB to "walk the walk" and not just "talk the talk". If you really believe that the HCDSB should be providing a caring and inclusive learning environment, then this is your opportunity to support this belief with a strong visual commitment.

I am writing to you today as a concerned member of the Milton community. I do not personally identify as LGBT, but I strongly believe that the actions of our public institutions affect the experiences of the entire community that it serves.

Religion has a notable and treasured place in our society. Canada is home to a variety of faiths, and it is our acceptance of this diversity of faith that is a part of what makes us a resilient and attractive place that is respected around the world.

I think I speak for most Canadians when I say that we strongly support the right of all of us to practice our faith as we see fit. An important part of that right is the ability of various faith groups to provide an education grounded in their beliefs. The right to educate your children consistent with your values and upbringing is not something to be lightly set aside.

That said, the catholic system is fundamentally different than the educational systems set up by other faith groups. The catholic system is funded not exclusively by Catholics, but by all of Ontario. No other faith group has access to public funds to operate their schools. As is the case with many rights though, public funding comes with obligations. A critical part of that obligation is a commitment to serve the entire community. This must not only be true, but it must be seen to be true.

Unfortunately, the catholic system has a history of discrimination against the LGBT community. While great strides have been made in recent years, the catholic system has to do more. To reiterate my previous point: The catholic system is publicly funded, therefore it must not only do good, it must be seen to flagrantly and unapologetically do good.

Flying the pride flag is a symbolic declaration that the catholic education system is not only willing to embrace every member of the community but is deliberately and loudly committing itself to doing so. If anything, the strong opposition to flying the flag is in itself a strong argument that the flag must be flown, since the intolerance of many members of the catholic system has been laid bare for everyone to see.

I believe that the catholic school system has a choice. On one hand, it can choose to join other faith groups and run the catholic system privately, without taking public funding. Alternatively, it can act like a public institution, and ensure that it serves everyone in Ontario. The catholic education system has already been dismantled in Quebec, and I suspect that if the catholic system in Ontario continues to serve its narrow community instead of the public from which it receives its funding, that it will inevitably face the same existential threat.

I would hope that this closing line would not be unnecessary, but in the event that it is, I would like this message to be included in the official correspondence related to motion.

Dear Halton Catholic District School Board Trustees,

My name is Jane Dobson and I am a Catholic family physician. I am writing to you to present my grave concerns regarding the motion before you now about whether Halton Catholic schools should fly the rainbow flag during the month of June.

You are being told that the reason to fly the rainbow flag is to "support our diverse school community". The wording is brilliantly deceptive. It encourages everyone to "just get along" and fly the flag in the mistaken belief that this shows loving support to friends and students who are in a lifestyle that is positive for them and for those around them. How could a caring Catholic possibly oppose this? What possible harms could flow to students by seeing that their school supports the rainbow ideology?

In order to understand why a Catholic would oppose this motion the following questions need to be asked and answered to elucidate what **actually** is being asked of the board.

- 1. What does "support" entail? Support entails endorsing the rainbow ideology. Neutrality is not an option in our current cultural climate.
- 2. What ideology does the rainbow flag represent? The rainbow flag represents an ideology that sees someone's core identity as merely their sexual attractions and sexual self concept.
- 3. Does the rainbow ideology foster Catholic teaching on sexuality and the Catholic anthropology on what it means to be made in the image of God? No. A major focus of the Catholic sexual ethic is chastity and this is not a part of the rainbow ideology. The Catechism's specific teaching on homosexuality being "intrinsically disordered" is directly in opposition to it. The Catholic anthropology that man is made in the image and likeness of God-- "male and female he created them" is directly in opposition to the gender ideology where there is a multiplicity of genders that can transmute at will.
- 4. How can Catholic schools show love to its many diverse students? Love, according to St Thomas, is to will the good of the other. Loving in this context would be sharing the beautiful Catholic teachings on sexuality which bring life, help, hope and healing at this time of great sexual and moral confusion. We should be a beacon of hope to our students, not a place of conformity to our culture. We are to be salt and light to our world who so desperately needs brave voices proclaiming Jesus's love and truth.
- 5. Are there actual harms to Catholic students who live out the rainbow ideology? Yes. Specifically where chastity is not promoted one is seeing an epidemic of sexually transmitted infections. There is also major harm being done to our children in the promotion of gender ideology. There has been an exponential growth in transgender identification in our children. This is thought partially due to social contagion and also because excellent therapies for gender dysphoria and the treatment of co-occurring mental illnesses are now no longer being offered at our gender clinics. Prior to 2015, before Bill C-77 was passed, 80-95% of gender confused children identified with their natal gender by puberty when given watchful waiting therapy. They were allowed to become comfortable and accepting of their own bodies. So many were spared the harmful effects of puberty blockers, a lifetime of cross sex hormones and mutilating surgeries. Now when a child is sent to a gender clinic only affirmation therapy is given which quickly results in medical transition and possible surgeries. Many parents and concerned relatives are now speaking out against this rush to medicalize our children. De-transitioners are asking why no one tried to stop them or at least give them time to think it through.
- 6. What is the purpose of a Catholic school? Why would someone choose to place their child in a

Catholic school when their are so many excellent secular public schools? The reason for the existence of Catholic schools must be that they teach Catholic morals and doctrine throughout all subjects while providing excellent primary and secondary education. Catholic are looked to as bastions of sanity in our confused world. We promote the counter-cultural concepts of life rather abortion or euthanasia. We promote the counter-cultural concept that our genitals were made for generating human life in the context of marriage. That our sexed bodies are not mistakes that need to be altered but have real meaning.

7. Can Catholic schools still be allowed to exist if they do not conform to what is currently being promoted in secular culture? Yes. Catholic schools are in a very unique position in Ontario. They have been given special powers to teach Catholic doctrine and morals while being publicly funded. What a privilege. What a responsibility.

Dear Mr. Daly, Mr. Chair and all HCDSB Trustees,

I am not sure I can adequately express how disappointed I was in the decision to not extend the meeting on April 20 and thus avoid voting on this very important issue. However, I will take this opportunity to express how important it is to vote yes to flying the Pride flag during the month of June, and how much I hope each of you will take the time between now and the next meeting to reflect on the impact your vote has on the children, youth and staff of the HCDSB- they are who is important in this decision and they are overwhelmingly asking you to vote yes.

In response to a delegation- the decision to create a flag in KW has been met with considerable backlash from the community, not only the 2SLGBTQ+ community, but the community as a whole. The rainbow flag is the flag of the 2SLGBTQ+ community. It is their symbol. Theirs. It is not for anyone to change or recreate. Creating your own flag does not send the message of inclusion and safety that we are requiring of the Board. This is not a colouring contest- this is about respect and love and honouring other people; it is about acceptance and belonging and showing our children and youth that no matter what; they are loved, they belong and we will protect them.

In another delegation, the gentleman asked for more data so that you may know the true scope of the impact the lack of inclusivity is having on the students and staff prior to making a decision to raise the flag. Respectfully- who do you think would be willing to out themselves in a survey? How can we expect the students to have the courage to come forward, when the Board will not even make a commitment to fly a symbol of acceptance, belonging and love for 30 days to show these same students they are cared for?

The other person in that delegation was harmful and I am appalled that he was given a voice in this conversation. He spoke of division; not inclusion. He spouted hate; not love.

This is from your own website- At HCDSB, the health and well-being of all students is our highest priority. Our Catholic values instill a strong belief to care for one another and ensure that our schools are safe, engaging, welcoming and inclusive places to learn. If this statement is true, then your only option is to vote yes; if it's not the truth then vote no and take this off your website.

Romans 15:7 Accept one another, then, just as Christ accepted you, in order to bring praise to God.



Re: Supporting Our Diverse School Community

Dear HCDSB Trustees and Staff,

My name is EJ and I am a grade 8 student at Catholic Elementary School. I am a proud ally of the LGBTQ2S+ community and a member of Free Mom Hugs Southern Ontario's Youth Advisory Committee. After watching the last school board meeting with my parents, I asked if I could delegate at the next one to share my thoughts on what I heard. Thank you for including this letter in your meeting agenda instead of my delegation presentation.

Through my volunteer work with Free Mom Hugs Southern Ontario, I have learned that although we live in Canada, there is still a lot of discrimination towards the LGBTQ2S+ community. So much so that our group offers hugs as allies (pre-Covid) because sometimes when LGBTQ2S+ people come out to their families, they are not supported or even hugged by them anymore. I have been to Pride events in Hamilton with my family and have never seen anything that the Catholic Church would say is sinful or wrong.

I think flying the flag every June, like Halton Public District School Board already does, does not go against what we are taught in our faith. Even if the Catholic Church doesn't support gay marriage or unwanted children being adopted by someone who is gay, neither of those things affect kids in school because you have to be an adult to get married or adopt. What DOES affect kids is feeling loved and accepted as a child of a gay couple and kids feeling loved and accepted when they realize they are a part of the LGBTQ2S+ community. We learn in Religion and Family Life, that sex is saved for after marriage. So, this motion isn't about that, it's about supporting kids that are LGBTQ2S+ and a reminder to all staff and students that everyone is loved in our schools. I know some people in our school board think LGBTQ2S+ kids should go to a public school if they don't feel accepted at their Catholic school, but often, they don't have a choice about what school they go to. Their parents decide for them. They obviously don't know they are part of the LGBTQ2S+ community when they start in kindergarten, so even if their parents let them switch schools, I don't think it's fair that they have to leave all their friends and not have a faith-based education because of who they are. In my school, I have heard hateful language and slurs against LGBTQ2S+ people by other students. I think there's a lot of this kind of thing going on without the staff knowing, just because our LGBTQ2S+ friends have asked us to not "out them". Flying a flag and putting up Safe Space posters is a first step towards our board being truly inclusive. Hopefully when people see the flag, they will be encouraged to act more inclusively and not bully LGBTQ2S+ people anymore.

I know the cost of large flags is expensive, but I think we could ask parents to organize an online fundraiser at each school or we could have a Spirit/Civvies Day and ask families to donate a loonie or toonie towards the cost of the flag at their school. Or I would be willing to create a GoFundMe page for this important cause to share on Free Mom Hugs Southern Ontario's social media, which I know will get attention and support.

If this motion is approved, I think it will not only be a good thing for the LGBTQ2S+ kids to feel seen, heard and more included, but for everyone in our school board to recognize that we are inclusive and will not stand for bullying the LGBTQ2S+ community anymore. We have an opportunity for our school board to be leaders here, putting into action what our Pope, Bishop and many priests believe...that we are to love everyone, just as they are.

Thank you for taking the time to read my thoughts on this very important subject. I appreciate that you are giving HCDSB students a voice in this, as it impacts us and our friends the most.

Open letter to the HCDSB Trustees,

I wanted to send in a letter regarding the motion of flying the Pride flag in June at all HCDSB schools.

I'm hoping this gives you some insight into my experience as an LGTBQ youth within the HCDSB that I'm not sure you are grasping.

I attended St. Joseph's and St. Thomas Aquinas from Junior Kindergarten to Grade 12.

I am a lesbian. It took me a long time to be able to say that out loud. I knew I was "different" in high school but I never had the strength to come out. I never felt comfortable enough to be my true self.

I was bullied starting in Grade 5. It went from being teased about my weight to the fact that I wore glasses, had buck teeth and later braces. In high school, it escalated. I didn't pay much attention to the boys and rarely wore the school kilt. The homophobic slurs started. I was called a **started school school**, to name a few.

The bullying took its toll on my mental health. I was scared to talk to the teachers about this because I worried I would out myself so I suffered in silence. I was quiet and never tried to draw any attention to myself. I hid. I cried in the bathroom countless times. It took such a toll that although very hard to admit, I considered a number of times to end my life.

The struggle for young people is real and even more so for those in the Catholic boards in Halton and across the province and everywhere for that matter. As said by a peer, I survived my time within the walls of the HCDSB. Survived should not be the word used for a student's career in Elementary and High School.

I relied heavily on my faith and that is how I made it through. I had faith that God would not put anything in my path that I could not handle. I had faith that it would get better. I knew suicide was a sin. I made it through and it did get better.

I have a strong support system at home. A lot of students cannot say that as evident in

many of the letters against this motion. These students NEED this step forward. We shouldn't have children just survive in your schools. They should THRIVE. Those students that don't have the support at home need to have the support at school or they may not survive.

This IS a matter of life and death and I hope this letter will help you see that.

Director Daly, Chair Murphy, and Trustees,

We are writing once again as HCDSB parents, alumni and ratepayers to encourage you to vote in favour of the Supporting Our Diverse School Community motion. As trustees, you have an obligation to ensure that the students and staff of the board feel that school is a safe an accepting space. During the last board meeting, I heard several trustees asking why the flag is necessary and asking to do a survey and a complete review of the Board's policies instead. Why are the two options mutually exclusive? Approve this motion as a first step on a larger journey.

Teachers, students and parents have all voiced overwhelming support of the motion. I would wager the "silent majority" Trustee DeRosa referred to is in fact an extremely vocal minority, many from other regions (Trustee DeRosa even specifically said out of province...) who have no vested interest in what is best for our community. We have heard firsthand accounts from current and former students that this is a very real issue now that we have the opportunity to begin addressing.

A few stats to remind you of the urgency of the motion:

- One third of sexual minority Canadians consider their mental health poor or fair, three times higher than heterosexual Canadians. They are also three times more likely to have seriously contemplated suicide in their lives. (StatsCan)
- Sexual minority individuals were three times more likely to have been physically assaulted (StatsCan)
- 74% of trans students and 55% of sexual minority students have reported being verbally harassed at school, compared to 26% of non-LGBTQ students (Egale)
- Nearly two thirds (63%) of LGBTQ students felt that their schools were not safe (Egale)
- 53% of LGBTQ educators in Ontario Catholic schools felt that discussing LGBTQ issues would jeopardize their jobs (Egale)
- Only 57% of teachers from Catholic schools reported they would be comfortable discussing LGBTQ topics with students (Egale)

The value of the motion was further underscored by several of the letters and even elements of the delegations which were presented to the board. It is an understatement that they should not have been included in the official package as several crossed a line.

Please stand up for what is needed. Make a statement that we are going to protect marginalized individuals. Let Halton Catholic be a leader in doing what is right.

Dear. Mr. Daly, Superintendents, and Trustees,

I am a parent of three children in HCDSB as well as a graduate of HCDSB, who is a teacher in a neighbouring Catholic Board who holds a Religious Education Specialist. This is a letter of reiteration of my support for raising the Pride Flag in June, amongst other positive actions for inclusivity and diversity.

I was delayed watching our delegation at the meeting this week and, when I was able to watch it, I was absolutely disheartened at much of the commentary and actions of some of the Trustees and delegates—as well as the abrupt end to the meeting without a vote. For a trustee to apologize to a mother for their child being "confused" about their sexuality, or for a delegate to say that students were "suffering from same sex attraction" just shocked me. I heard mention of not agreeing with same-sex partners adopting a child, as if two loving adults could not raise a child together. Even if they don't agree with the lifestyle, or even if they can't believe that God made someone the way that they are, at least they could learn to choose their words and speak mindfully. This was such disappointing talk from adults.

The Catholic Church has historically been known to be against same-sex genital relations (as it was worded in one of the Religious Ed. AQ courses that I took). Raising the flag does not connote that the HCDSB is saying "go have sex" as one of the April 20th delegates insinuated. Raising the flag is a symbolic gesture of support, and a symbol that, as an institution, the HCDSB values this community of people for the individuals that they are.

At the meeting, it was suggested that we "recreate" or "redesign" the flag, however we simply cannot do that. It is not our symbol to redesign. As was also suggested, we cannot push this action off to the Province, to wait for them to develop more inclusive curriculum (as another Trustee suggested). In the principle of subsidiarity, as taught by Pope John Paul II, we must first work locally to support and aid those who are vulnerable and who are close to us. These are the students in our own communities. This action needs to start locally. For those people who have mentioned or calculated the cost of the flags, please remind them that the school board has saved tens of thousands of dollars this year in photocopies alone, with the onset of virtual schools and the secondary hybrid model of learning. Perhaps that number would be a good one to have handy, Mr. Daly, at the upcoming meeting, although I realize that it is now April and that funding may have been reallocated by now.

As education professionals, we know from the Equity, Diversity and Inclusivity training that we have had, that there is so much more to be done to ensure that **all** of our students feel safe, included, and equitably treated within our schools. We know that climate surveys provide great data to help plan for action—when they are answered honestly, without fear. We know that for some students, often our most vulnerable, their safe haven lies at school, where they feel most loved and supported. We know from the delegations that there are several HCDSB grads who didn't feel comfortable in our schools. Let's change that, moving forward.

By raising the flag, we are showing support for the LGBTQ2S+ community. We are showing that we love all people of all kinds, in a action of inclusivity. It is a fact of life that people are diverse beings. It is a choice of institutions, embedded with their own legacies, to choose to be equitable and to instigate change through positive action to include everyone. The outcome of this action, in this case, raising the flag, is that all people feel like they belong.

Dear Trustees, Mr Chair and Director Daly,

Pride Month, with its rainbow flags flying, is an outward display of our support for human rights. The LGBTQ community has endured profound emotional and physical pains, bullying, violence, intimidation, shaming and death.

Is a flag really just a flag? How is it that such a simple piece of rectangular fabric can hold such meaning and create such a divide? A flag by nature is used as a symbol. One can observe many symbols within our faith and within our schools. Why would we want to segregate a population of people? WE teach our kids to be inclusive, I would like to draw attention to the following:

- 1. Students are encouraged to wear pink as a symbol of solidarity for anti bullying.
- 2. Students are encouraged to wear orange to acknowledge the legacy of residential schools
- 3. Students are encouraged to wear blue for autism awareness
- 4. Students are encouraged to wear mismatched socks in support of those with down syndrome.
- 5. Students are taught about the poppy for those that lost their lives in war
- 6. Students are FINALLY taught about our black heros and tribulations during Black history month
- 7. Students are encouraged to wear red for Valentines Day.

How is it that we can recognize those that have a different ability and yet our schools can not proudly wear a flag to recognize that love is love? How do we explain this disconnect to our young people?

I would like to draw attention to my young son, in SK here within the HCDSB. He was the most adorable ring bearer we had ever seen at 2.5. Propositioned with a balloon, he dropped the pillow with the rings and ran down the aisle to meet his dad who was standing proudly with his bride sister. Aunt Titi took it in stride. Something she has been doing all her life. Growing up in the catholic church, she, and her siblings (my husband) were alter servers and attended mass regularly. However, standing with Aunt Titi at the end of aisle is the love of her life, Aunt Lauren. Our son has learned from an early age that God gave us Jesus and in doing so gave us freedom. Freedom to love and be loved. I would be ashamed and disappointed that my son would target another human being because they loved differently.

I would also like to point out that on a weekly basis my job as a mental health nurse on the child and adolescent unit at Oakville Trafalgar includes supporting kids through crisis. All to often they are humiliated, disgraced and rejected for loving someone of the same sex. How in 2021 are not more open minded. We have kids in our schools that are considering suicide because they do not feel accepted and embraced for their choices. ONE child is ONE child too

many to be in such a tug of war. Children need a safe space to express and process their emotions. The raising of the flag will open the door for these conversations.

The school walls should be a place of safety, where students, our children feel comfortable to learn, grow and develop. Living in shame and ignorance will only breed shame and ignorance, that is systemic bullying.

I would like for those who oppose this motion to stop and reflect on the reasons why. Ask yourself:

1.) am I opposed to this because I am uncomfortable?

2.) am I opposed to this because I don't understand the struggles?

3.) what would you do or say if your loved one expressed that they love "differently than the mainstream way"

4.) why do I feel this way, what drives my limited understanding?

5.) what would say to a young person who is sitting across from you crying expressing that they would be better of dead then live with the shame of being different.

6.) What would you do if you have to dress the wounds of a young person who self harms because they would rather feel the physical pain than the emotional pain that comes with living in secrecy.

In closing if the school board is content with perpetuating such disgraceful actions consistent with bullying then keep the flag lowered. If living through a global pandemic as taught us nothing else it is that we are resilient and that we need each other. Now is the time to reset.

Jesus walked with those that others would not.

Dear HCDSB Trustees and Mr. Daly, Director of Education,

Please include this correspondence in the board agenda package for the April 26, 2021 board meeting.

I am a Catholic parent of four children who have all attended Catholic elementary and secondary schools in Oakville. Currently, my younger two children attend **Secondary Schools** I would like to share with you my deep concern with what I see happening in the Halton Catholic District School Board, namely the erosion of authentic Catholic teaching in the school system.

On April 20, 2021 I watched the virtual proceedings of HCDSB board meeting and I was quite distressed at what transpired with regards to the motion *"Supporting Our Diverse School Community."* This motion, if passed, would require every elementary and secondary school in HCDSB to fly the Pride Flag. As well, every classroom in the school board would be mandated to have an *LGBTQ Safe Space* poster displayed. The presentations by several of the delegations that supported this motion and the subsequent questions posed by some of the school trustees illustrated a clear lack of knowledge and understanding of true Catholic teaching and doctrine. However, I was quite relieved by one delegation in particular that featured a Catholic parent and a Catholic priest and spoke against the motion. This priest, Fr Janusz Roginski, provided sound and accurate information on Catholic teaching and doctrine, and he did this with kindness, clarity and charity.

I wasn't going to write a letter, but after seeing what happened at the Board meeting this past week, I am appalled and urge you all to vote AGAINST the motion to fly the Pride flag at our Catholic schools.

At this meeting, one of our own student trustees raised a concern to about racialized students, bravely sharing his own experience as a student from a racialized background - I was horrified to hear an adult and White woman, patronize, belittle, and question him, asking him if he really has experienced discrimination or bullying due to his background, even sarcastically saying "IF you have, I'll be there to fly your flag". This was not okay. In the same way that trustees asked one of the other delegations to take into account the anecdotal experiences of even just ONE student from the LGBTQ2S+ community for the group of students and parents.

I am writing because I believe this issue must be viewed through an intersectional lens - that is, in the context that our identities are not singular and defined by one label or element, but rather, through many elements that intersect and make us who we are. Your own identity is composed of many elements, and you can have power in some elements and be marginalized in others. Please see this image below, created by Sylvia Duckworth and shared by Youth Mental Health Canada, and reflect on where you have power due to your identity and where you may be marginalized. The image, if not included in the package, can be found by googling "intersectionality wheel of power/privilege".



As a school board, by focusing on supporting and celebrating only one element of our students' identity, we are doing a disservice to all our students who may be marginalized in many other ways, some in more than one. If we truly want to support inclusion and equity, we need to focus on the needs of ALL our students in their diverse identities. We need support for our female & female-identifying students amidst the rape culture that is prevalent today, support for our Asian students who are facing racism & discrimination and being blamed for the coronavirus, and for our Black students who as a community are dealing with the weight of police brutality and the sensationalization of Black trauma. And yes, we absolutely do need to support our LGBTQ2S+ students, but raising a flag for the month of June does not support these students or their diverse identities in a way that originates from, and is congruent with, our Catholic faith and identity as daughters and sons of Christ.

Our students' identities as Catholic students are important too, and by raising this flag we are sending the message to our community and the broader Halton community that students' sexual orientations and gender identities are MORE important than our Catholic identities and the teachings we follow. Instead of raising the flag, if we want all of our students to be supported in their diverse, multifaceted identities, this conversation needs to be centred not around what we can do to support ONE component of students' identities for a month, but how we can continuously support all students through creating an inclusive, loving, and kind community consistent with our Catholic faith.

As a Catholic school board, we cannot ignore our identity as Catholics - so when we discuss inclusion and equity, we need to be aware of what the Catholic Church teaches and let that guide our discussion. The church does not teach us to celebrate our sexual or gender identities, but to celebrate our identity as God's children. The church does teach us to love all human beings, and that each one of us is created in the image and likeness of God and deserves dignity and respect. However, the church also teaches us that the act of sex is sacred and reserved for the sacrament of marriage, so to celebrate a component of our identity that is rooted in who we are sexually attracted to is not in line with our Catholic faith. Instead of celebrating "Pride", let's celebrate diverse identities including our identity as Catholics. Let's celebrate our diversity using an intersectional lens, and have these conversations about inclusion and love, while remembering that our students are not a homogenous population and yet, cannot be divided into categories based on who they are. We are all daughters and sons in Christ, and THAT is the most important element of our identity in this CATHOLIC school board.

I also want to mention that voting against this motion is not homophobic, nor bigoted; flying the pride flag simply does not align with our Catholic faith and there are other ways to support our diverse community of students, that do align with our faith and Church teachings. I urge you to continue this discussion on diversity, inclusion, and equity for ALL students including our LGBTQ2S+ students, racialized students, minority or underprivileged students, all through a Catholic and intersectional lens.

Dear Chair Murphy, Vicechair Duarte and Trustees of the Halton Catholic District School Board,

St. Paul writes in 1 Corinthians 9:16, "If I proclaim the gospel, this gives me no ground for boasting, for an obligation is laid on me, and woe to me if I do not proclaim the gospel!".

My name is Michael Aguiar, and I come before you as a genuinely concerned young adult, youth minister, social worker, and future parent. I am a product of the Halton Catholic District School Board, a graduate of Bishop P.F. Reding Secondary School and awarded Student of Excellence in 2011. I speak on behalf of the faithful and practicing Catholics of our community and Halton Region.

I look forward to sending my future children to a Catholic school with the expectation they will be taught the truths of our faith that I have learned, and that I will be supported in the values and morals we uphold as a family. Supporting the raising of a Pride flag takes that away.

For the sake of inclusion, you are excluding the faithful Catholics. You are excluding the freedom to practice and uphold the Catholic values this Board claims to live by. If this issue, raising the Pride flag, is not about "faith" then the presentation of motion *Supporting Our Diverse School Community* should not be quoting scripture or using Jesus' words to find validation in their support.

In flying the Pride flag, you as trustees are making a statement much larger than the Halton Catholic District School Board itself. It is a direct, visible and public statement for the entire Catholic Church, which as a trustee, is not stated anywhere in your Policies and Procedures giving you the authority to do so. You have been made aware and presented before you that the Pride flag stands behind actions and behaviours that go against Catholic teaching and morality, that being chastity.

Flying the Pride flag for 30 days will NOT fix the root of the problem of students being bullied or feeling unsafe in classrooms, nor does NOT flying the flag condemn the LGBTQ+ community. We are ALL called to live a chaste life, not to lead our children astray. Since the presentation of this motion, parties in support have used scripture to justify encouraging our children to sin. Jesus never did that. In fact, Jesus admonished the sinner and when he forgave them said, "Go and sin no more" (John 8:11). He did not expect them to continue living in sin.

The real issue is that the flag is a ruse. If this issue was really about acceptance, respect of human dignity and love for all God's children, we don't need a new flag for that, we already have one, our Canadian flag. That should be what we all strive for as Canadians, as Catholics. The flag makes the issue about encouraging and "celebrating" acts against chastity and actually reduces the dignity of the human person to who they have sex with, who they are attracted to and which gender they identify with.

Instead, our dignity is found in the fact that we are created in the image and likeness of God, with intellect, free will and the capacity to love and create. As Catholics, we are called to be set apart, not to follow the narrative of the culture. While we may know that not everyone is being chaste, yes we love them anyway. However, we do not just give up and encourage them to continue sinning, we strive always to be better versions of ourselves, and we build up those around us to discover the best versions of themselves. The Catholic Church exists to direct society not to reflect society.

As children of God, we cannot raise a flag, put up posters or hold events that celebrate choices or a lifestyle that is against the values and morals of our Catholic faith. Furthermore, to use and twist the Pope's and more so, Jesus' words to justify this act is atrocious and irresponsible!

The HCDSB can provide a safe space for all without raising a flag and celebrating sin. What the LGBTQ+ community needs is not a flag, but to see patient, compassionate, empathetic, and charitable dialogue from teachers, social workers, priests, ministers, and other well-formed educators who can explain the truth of our identity as children of God. Formators who are able to live by the equity, dignity and respect the HCDSB upholds, without erring from emotional intelligence, Catholic morality, ethics, and theology. That begins with the formation and careful attention to the administrators and teachers you allow into our schools.

An authentic Catholic is someone who lives by the truths and love of Jesus Christ. I would like to quote Kim Zember, a faithful Catholic who struggles with same-sex attraction, from a Youtube video by Ascension Press entitled: "Can I be Gay and Catholic?":

"Be real. Be truthful, don't change the truth of Jesus Christ. His word does not change, His truth does not change. God was, is and always will be. If His truth comes without His love, you've separated who Jesus is. You've created a new Jesus. If you love without His truth, you made him a hippie, which he is not." <u>https://www.youtube.com/watch?v=Ct8stB59jiM</u>

We also cannot just be truthful without the love of Christ. Truth and love cannot be separated, it is the fullness of Christ. That is what truly sets us free, no matter what we are struggling with. John 8:32 states - "and you will know the truth, and the truth will make you free".

The issue at hand here is not a flag, but the bullying that has been continued within our schools and the inability of HCDSB administrators and teachers to prevent, and properly address these issues based on Catholic morality and ethics.

I myself was bullied for being "gay" in elementary and high school when I did not even identify as such. It was a label that was painted on me and continued into high school simply because I had the talent to sing and was the only boy in the choir. I cannot hide and say that did not damage my youth or experiences in school. It did. However, through it I found resilience because of my faith that was being taught to me in my Catholic school.

Flying this flag may only encourage more hate speech and crude behaviour because of its visibility. To paraphrase a student in a previous delegation presented on April 20th, "children are not born discriminating". No one wakes up one day and decides to bully someone for their religion, sexual identity, race, etc. That is an attitude that is developed from somewhere in their life experiences that must be addressed by proper professionals who can support them, while in a Catholic school, should be assessed by a PRACTICING Catholic professional.

My proposal before you is to make the presence of such professionals more prominent. The concern this motion has brought forth is evidence in itself that the HCDSB is not doing enough in regards to Bullying Intervention as mentioned in Policy No. II-40. I would like to make it aware to the Board that there are resources and ministries out there our schools should be encouraged to promote such as Overcome Ministries or EnCourage International, which exist primarily for the LGBTQ+ community within Catholic circles.

That being said, let me be clear in my following statement. People change people. Not programs, curriculums, symbols or flags.

Throughout my extensive religious studies, I have learned how to communicate and transform the perception and lives of many young men and women, including those within the LGBTQ+ community. I myself have encountered several members of the LGBTQ+ community who voiced their concerns with me and the lack of respect and dignity they feel from religious groups or even their own parents. Today those persons no longer feel unloved, unwanted or unsafe because I have learned how to help them come to the understanding of who they are as a beloved child of God. If I have learned how to communicate to them with love, with equity and building within them the dignity each person deserves, why can no one else? Are feelings now more important than the faith we as Catholics are called to live by?

Yes, the struggles within our students are real. However, there are people who have found the resilience to move forward WITHOUT a flag. The HCDSB must be willing to invest in finding these testimonies, speakers, and professionals that can help and that will not change who each individual is. We must not identify ourselves with our attractions or our feelings. Why is a term like "gay" coming before one's Christian identity? We are all sons and daughters of Christ, we should let HIM define who we are. Let Him be God and not us.

Please, for the sake of our children, our Catholic identity and the souls of those responsible for the education of our children, vote against this motion.

This motion is driving the community apart.

I watched the City TV interview with **a second second** just prior to the board meeting and she confirmed a positive, accepting school experience at Loyola. Having taught at Loyola myself for over 20 years, I can attest to the same. A compassionate, caring, supportive school community. As both a regular classroom teacher who consistently integrated life skills students into my classes and later as a special education teacher working with marginalized students in regular classes on a daily basis, it's unclear to me what on earth has changed in our schools that now necessitates flying the Pride flag.

Dear Director Daly and Chair Murphy,

I am following up as I have still not received answers to the questions from my correspondence dated March 2nd (see below).

In particular, <mark>what was the rationale for publishing the "Dying with Dignity" letter in the</mark> February 16th board report? - a letter that had nothing to do with education, did not request to be published, and was from an organization whose very mandate is antithetical to the Catholic faith? I received your message below that my correspondence of March 2nd was not published because it was received after the agenda package was posted and that "this year" you are "committed to be consistent and not add any correspondence after the agenda package is posted". This response raises many questions.... First of all, as I have shared many times, I have been told this in the past....only to later find other pieces of correspondence published that were received after the package was posted, sometimes well after the package was posted including the day of the meeting. So it seems to me that your rules change on a whim. What is the rationale for suddenly going back to only publishing correspondence received before the report is posted? When was this decided and how and when was this shared with the community to ensure transparency and fair and equitable treatment of all stakeholders? Also, what is your definition of "this year"? In September of this school year, you were publishing letters received in the afternoon of scheduled board meetings - and reading them aloud upon request....

Not allowing correspondence to be published after a board report is posted severely restricts stakeholders from providing feedback on issues that are on the agenda that they might not be aware of until the report is publicly available. This is not being accountable, open or transparent.

A Policy would certainly eliminate any "confusion" in the future. More accurately, it would ensure fair and consistent treatment of all stakeholders. Your reference to the draft Correspondence Policy would suggest it is going ahead....but you haven't actually stated that, and the future of the policy is otherwise unclear, as I also referenced. Some trustees felt the current process - of the Chair, Vice-Chair and Director just making a decision - was working well. I hope these latest inconsistencies make it clear why a Policy is needed.

If the board is indeed committing to moving forward with the draft Policy, why not start to follow the provisions laid out in that draft policy? I didn't hear any objections from trustees to any of the provisions in the draft policy, just whether or not it was actually needed (I assure you, it very much is). The draft Policy allows for correspondence received up to 11:59 pm the day before the board meeting to be published in the report. Why then are you suddenly, after the draft policy has been presented, operating under such a starkly contrasting rule that has not been in place since....at least November? Again, when exactly did the rule change?

The draft Policy states that correspondence received after the deadline for publication in the immediately next board meeting, would appear on the next scheduled Regular Board Meeting agenda. While it was not confirmed to me, I would assume that my correspondence of March 2nd is scheduled to be published in the March 16th board report. I would instead ask that you publish this correspondence instead - the <u>full thread which includes the March 2nd</u> <u>correspondence</u>. Also please include this correspondence in full on the Policy Committee agenda when the draft Correspondence Policy is also on the agenda.

In closing, I would like to draw your attention to the Principles in the draft Correspondence Policy. In particular, the third bullet which states that:

"HCDSB believes that communication is reciprocal and that all correspondence to individual Trustees or to the Board of Trustees as a whole, shall be addressed".

I assume the Policy does not have to be in force for the board to honour this Principle and as such, I look forward to receiving answers to the questions raised both in this correspondence and that of March 2nd, attached below.

Dear Trustees and Secretary of the Board,

I would like to first of all thank Trustees Agnew and Karabela for their work on developing and presenting the Draft Correspondence Policy at the February 9th Policy Committee meeting. The draft policy is thorough and I believe lays out a very clear framework as to how correspondence received by the board would be dealt with, including reasonable and fair criteria for deciding when correspondence should be published in board reports. Having such a policy would ensure a consistent and fair approach and effectively manage stakeholders' expectations.

However, the discussion that followed the presentation of the policy was confusing and it is unclear what the next steps are. In particular, there was discussion amongst several trustees that the current approach of the Chair, Vice Chair and Director deciding which correspond to publish and not publish was working well and that that should be codified. It seems to me that at that point, the conversation had gone full circle.....

The point of having a correspondence policy is, at least in part, to establish objective criteria to be used consistently to make those determinations. Leaving it up to three people, who could very well change from one year to the next, or, even amongst the same three people may have a difference of opinion from time to time essentially defeats the point of the policy in the first place. It was stated by Chair Murphy that the intention is to be "open" and that currently, all correspondence that "meets the criteria" is in fact published.....but the question remains - *what exactly is the criteria*?? I have asked this question repeatedly over the years and received conflicting information and more recently - have not been provided any answer at all. So, in light of the conversation at the February 9th Policy Committee; I ask again, and I would appreciate an answer this time - *what is the criteria that is used to determine whether or not an item of correspondence will be published in the board report*? Since the system is working so well.....

It would seem to me, as I have articulated in the past, that without a clearly outlined policy, the decision is subject to inconsistency and potential for bias, manipulation and censorship. In fact, we didn't have to go too far into the future to see this in action once again. In the February 16th board report, there were three pieces of correspondence from stakeholders, and one from the organization "Dying with Dignity", (who I would not define as a stakeholder of the Halton Catholic District School Board in any way, shape or form), in opposition to Trustee Karabela's motion "Opposing the Euthanasia Bill C-7". There were no letters published in support of the motion. Only one of the stakeholders actually asked to have their letter published, the others did not, and neither did the organization. So please tell me, what was the criteria used to determine that these pieces of correspondence should be published by the Halton CATHOLIC DSB? Fast forward another two weeks and we learn that there were several pieces of correspondence in support of the motion that were in fact denied publication in the February 16th board report. One of them mentions that their correspondence was inadvertently sent in too late. Back in September, the board published and read aloud correspondence received on the day of the meeting. Just how late were these items of correspondence for the February 16th report that they could not be published? What exactly is the deadline for submitting an item of correspondence and having it published in the report?

I was particularly dismayed to see the board publish the letter from "Dying with Dignity". I have repeatedly asked, what is the criteria for organizations to have their letters published. I've given an example of an organization with concerns about the *education of students*, an organization that was in fact directed to send a letter to the Chair and the Director to have their concerns addressed (they never were), whose correspondence was not published, yet a letter from an organization that has nothing to do with education, that is not a stakeholder of the board, and that did not request to have their letter published, was published? Not to mention that the organization's very purpose and mission is in direct conflict with the tenets of the Catholic faith. For that reason it was quite disappointing when a majority of trustees voting against removal of the letter from the board's report. One trustee mentioned that they were in favour of "freedom of speech" and of stakeholders making up their own minds and decisions. None of that is relevant whatsoever. For one thing, while stakeholders can certainly have their own opinions on any number of issues, those who support the Halton Catholic DSB, either as ratepayers and/or parents sending their children to its schools, do so knowing that the institution defines itself as being "distinctively Catholic", and that it has an obligation to carry out its mission through a Catholic lens and remaining true at all times to the Catholic faith. (What otherwise is the point of having a Catholic board?) It is not up to a Catholic school board to present the different sides of any debate in order for its stakeholders to make a decision on anything in their personal lives - certainly not an issue on which the Church's position is pretty clear. As you may be aware, there are many social media platforms that censor users in various ways - including deleting their accounts - when they don't agree with their position on any number of issues. So why on God's Earth would a Catholic school board provide a platform for an institution whose very existence is diametrically opposed to the Catholic faith? Do you think "Dying with Dignity" would publish a letter from the Halton

Catholic board? or the Canadian Conference of Catholic Bishops? Or any letter with an opposing position? Why would the Halton Catholic Board publish their letter?

In reviewing the way correspondence was handled in the February 16th and March 2nd board meetings, it is difficult not to reach a conclusion that the Halton Catholic board is in fact in favour of Bill C-7 and Euthanasia. If the board wants to avoid the appearance of bias, manipulation and censorship, it needs to establish a policy which clearly outlines the criteria for publishing correspondence in board reports, and it needs to actually follow the policy - consistently. I would further suggest that the board's correspondence policy prohibit the board from publishing correspondence from organizations whose mission and purpose runs contrary to the Catholic faith and Church.

Please include this correspondence in the March 2nd Board Report.

I am a concerned Halton Catholic District parent of four children who attend HCDSB schools in Oakville.

I believe you would be doing harm to students by approving the motion to allow the pride flag to be flown or any material representing it to be distributed in our schools.

Raising that flag suggests approval of sexual relationships that the church disapproves of, and which run contrary to the Catholic moral teaching of chastity. In Theme 3 of Fully Alive in grade 8, it is taught that the homosexual acts are sinful, however the homosexual person should be treated with respect. How are students expected to reconcile the difference between sinful acts and flying a flag that seeks to celebrate them?

The Vatican recently stated that priests cannot bless same sex unions, that God "cannot bless sin".

In 2010, as the head of the Catholic Church in Argentina, the Pope, then Cardinal Jorge Bergoglio said "gay marriage was a strategy to destroy God's plan". He also expressed concern about a bill allowing same sex couples to adopt, he stated "it was important to ensure that children had "both a father and mother" as role models. He also said that gay people should not be discrimated against but reaffirmed Catholic teaching that same sex acts are sinful. My name is Nikki Borge Scott, my pronouns are she/her. I am a mother to what I thought were 3 sons, but it turns out I made a mistake and have 2 sons and a DAUGHTER. One of my beautiful children is living life as her true self. I couldn't be more proud of my beautiful girl, my strong and brave daughter. My other children understand that they have gone from having a brother to a sister. Kids are pretty impressive and adaptive when we give them the opportunity and education to help them understand. She is the happiest child who is liked and respected by her whole class and is currently unaware of the hate that people feel towards children like her, and as her mother I would very much like to keep it that way. I know life won't be particularly easy for her, our home will always be a safe and positive space. It will be the walls that protect her from the ugly that lurks out there. I hope that with this motion that her school and the entire Halton Catholic School Board can be an additional safe space for her.

Two of my children currently attend **construction** and my youngest will join them in September. The school is run by an amazing group of staff and admin. We absolutely love our school. No parent wants to see their child suffer because of bigotry and hate. No adult wants to see any child become a victim of anti trans hate, I choose not to use the word transphobic because there's no fear of the community, just hate.

When I realized my daughter was transgender, I began to read and learn as much as I could about trans people. One thing that shocked me was the mental health issues these children face due to lack of representation, discrimination, rejection, harassment and bullying. The statistics around transgender suicide and attempted suicide are very concerning and I do not want any child to become a victim of them.

All children deserve to feel welcome in their own school, and flying the 2SLGBTQIA is a great way to do that.

The 2SLGBTQIA flag represents safety and welcoming spaces. It signifies to someone who identifies as 2SLGBTQIA, when you enter this establishment, home or school, you are welcome. You are safe and you are accepted, respected and loved. You are among friends and allies here.

Before staff, students and visitors walk into a HCDSB school, they should see a symbol of that. This flag also represents more than transgender, gay, lesbian and bisexual people. It represents intersex people, who are genetically born with characteristics of both males and females in some form. They are biologically both. According to <u>amnesty.org</u> 1.7% of the population are born with intersex traits, that's the same percentage as people born with red hair.

It represents asexual, people who have no sexual or romantic attraction to anyone. It represents 2 Spirit people who are honoured in the indigenous communities. I don't think flying a flag for 30 days in June would set the Catholic Church or the school board back, or condone any sin. It would show the entire community that the Catholic Church and school board is choosing to welcome and love a marginalized group of people, the way Jesus called us to do.

The HCDSB acknowledges significant faith days of other religions, Ramadan being the most recent. Muslim students are welcome to wear their hijabs and at events where food is served there are halal options.

When we acknowledge those days of faith we are not condoning idolatry or encouraging people to convert. We are saying to the other religions "we see you, we value you, we celebrate with you"

The same goes for the pride flag.

Idolatry is a sin, we're not to worship any other God before our God, but no one seems to care about the other religious groups that are welcomed in our schools that may follow "other gods" and what the Catholic church considers is a sin. So why are we picking and choosing which "sins" we have a problem with?

In regards to the concerns of the flag promoting sex and sexual acts. Although the flag once depicted a pink stripe that represented sex, the flag has evolved and the pink is no longer on the flag. This shows that it is possible for things to change and evolve, much like many things in the Catholic Church and society as a whole.

Pope Francis is very vocal about the 2SLGBTQIA community and their rights to be in a family or have a family. He said "Homosexual people have a right to be in a family. They are children of God and have a right to a family. Nobody should be thrown out or be made miserable over it." The lack of visibility and representation within our school board which is like family to a lot of students and staff and students, absolutely contributes to 2SLGBTQIA members being miserable, oppressed, and unseen.

My name is N.F

and I am a Grade 10 student in the HCDSB.

I have been going to a Catholic School in Halton since Kindergarten, first for elementary, and now Although a great deal of my spiritual education happened at home, I was also able to learn about my faith at school. One of the things that was never discussed at school though, was the Church's teaching on Homosexuality, Transgender, and the LGBTQ+ community. What I understand of these teachings, I learned at home, from priests in our diocese, or through my own research. Why is this? Is it because this teaching is too complicated for elementary and high school students to understand? But I can tell you from personal experience that it is not. After all, I have been able to understand and find value in these teachings since elementary school, and even have discussions about them with my peers. Additionally, we already acknowledge that people at our schools do identify as LGBTQ+. So surely if students in our board are able to identify their place in this community, they would also be able to understand Catholic Teaching on this matter. So why then is it not discussed? Is it because this teaching is "politically incorrect"? Because Society views it as homophobic and hateful? That is just the problem. Most people do not understand the teaching of the Catholic Church on this issue, let alone on sexuality in general and the sanctity of our bodies (which is theology of the body). So how are we supposed to be promoting Pride and the equity and inclusion of people in this community if we do not even understand **our** faith's teaching on it? We are a Catholic Board after all. The truth is, that if we were to actually examine the Church's teaching on sexuality - both homosexuality and heterosexuality, we would discover that it is not hateful and exclusive, but beautiful and inclusive. This teaching actually promotes equity and inclusion. The Catechism does not only teach that "Basing itself on Sacred Scripture, which presents homosexual acts as acts of grave depravity, tradition has always declared that 'homosexual acts are intrinsically disordered.' ", but also that the people who identify as LGBTQ+ "must be accepted with respect, compassion, and sensitivity. Every sign of unjust discrimination in their regard should be avoided." A lot of people do not realise this. The Catholic Church tells us we must be loving and compassionate, not hateful. But we can do this without promoting something that does not align with Catholic Values.

The elementary school that I went to did not fly a pride flag, even in June. And we did not have special events to promote pride, even in June. And yet, my school was still an equitable and inclusive school. My peers and I were not worse off because of it, we did not grow up feeling excluded or hated. I had caring teachers and supportive students all around me. We did not need a poster to tell us that our school was a safe place, because our teachers and the other members of our community ensured it always was. From the time I was a little girl, my parents have taught me that Jesus loved everyone, and that because of it we should love everyone too. They taught me to value human life and human dignity. Because of this, I am able to understand extremely well why exactly we need to create an environment at our schools that is inclusive, supportive, and welcoming for everyone, and have tried to do my part in creating it. But I was also taught that Jesus was persecuted and crucified because he would not deny his values, values that his society did not like. I was also taught about the first saints, the martyrs who did not give up their values to the point of death, values that their society did not like, just like Jesus. And my parents taught me to do the same. To hold strongly to my beliefs, to the teachings of my faith, even if I am ridiculed or scorned by Society because they do not like them.

Because at the end of the day, it's not Society that is judging us. It's not Society that is glorifying us, It's not their praise or approval that we are seeking. It is Jesus'. And he will be asking us, did you defend your faith, did you hold strongly to your values, or did you bend to Society. **Who is your God?** Whose love do you seek, do you value more? Society or Jesus? Jesus who died on the cross for you and the immense weight of your sins? Jesus who loves you despite all your shortcomings? Or Society who scorns you because of them?

I am not saying that I am a saint, far from it. I do everything I do not because I am perfect, but because I am imperfect, and because I need to do everything I can to make up for it. And that is why I refuse to condemn Jesus because his teachings are unacceptable in the eyes of the secular and material world. I will stand by him and what he teaches, even if it means I am ridiculed and hated.

This year, I have had the privilege to be a member of the Student Senate. I applied to become a senator, because I wanted to be able to contribute to the catholic perspective in our Senate. As a Student Senator, I can say that I would love to help with these initiatives, as long as they are in line with the teachings of our faith. In fact, our constitution states that "Members of Senate are called to live out Gospel values" (Art. II s. 5), and the Bible many times calls out the act of homosexual intercourse as sinful. At the last meeting, one of the delegations said that Jesus never said "I love you but..." The truth is though, that is not true. Jesus does not only say I love you. He says "I love you - sin no more" or "I love you, which is why you have free will. You are able to sin, even though it hurts me, and I still love you". Although Jesus loves everyone, he never says that they are right in sinning. He loves the sinner and not the sin*. This is how we must consider this motion. The flag represents something our faith teaches is wrong. And yet we have heard that there isn't enough inclusion in our schools when it comes to those who identify as LGBTQ+. So what we really need to do, is work on creating more inclusive environments at our school, to support the members of our community, without supporting something our faith teaches is sinful, which is represented in the flag.

Society is asking us to fly this flag. Jesus is asking us to love everyone. We do not need the flag to support the members of our community who identify as LGBTQ+. All the flag does is send a message that we condone something that our faith does not support. At the end of the day, when making a decision, there are a few things you must consider. First, before we promote Society's values and understanding of this issue, we need to focus on our faith's values and understanding of it. We cannot expect our students to support something unless they understand our Faith's teaching on it. Second, we must ensure that every decision our board makes reflects Catholic teaching. We must refuse to cave in to Society's demands to make ourselves look better. In fact, Jesus never forced his values on others, so why should we let Society

force theirs on us? And Finally, we are able to support an equitable and inclusive environment without celebrating values that conflict with those of our faith. In the end, it's not about flying a piece of cloth to make those in our community feel welcome. It's about making them feel welcome, and being so sure that our schools are welcoming open and inclusive environments, that we don't need a flag to tell people that.

Dear Chair, Trustee Patrick Murphy, Halton Catholic District School Board Trustees, Director and Students, Staff and Families

I write to you today from Thunder Bay, Ontario to express my unequivocal support for *"Supporting our Diverse School Community"* motion and for raising the Pride (Rainbow) Flag for the month of June at all HCDSB schools to show support and acceptance for "Pride Month" an international recognized month to celebrate the 2SLGBTQIA+ communities.

I do not need to tell you how this "debate" is hurtful, discriminatory, bias and hateful and it goes against everything that the Catholic faith teaches. As a person who went to Catholic School all my life, my schooling and upbringing by strong catholic grandparents taught me to be accepting of all people, no matter race, gender, sexual orientation, religious background or where someone lived, their own upbringing or their socioeconomic background.

In 2019, we made history at the Thunder Bay District Catholic School Board (TBDCSB) by working together with the Director, administration, trustees, Gay-Straight Alliances (GSA), students and staff to raise the Pride Flag at the Board Office. This was a truly historic feat, the 1st known Catholic School Board in Ontario to officially raise the flag and recognize Pride. Not only was this an historic moment but as the person who lead that change in my community, I can tell you that it was not as difficult as you are all making it out to be. This change started with an honest and open conversation with the Director of Education. This conversation continued over a few months until the decision was made, without political interference or public backlash to raise the Pride flag and acknowledge that 2SLGBTQIA+ people exist, that they are welcomed and that they are loved unconditionally in the TBDCSB.

I will not lie, progress is hard and progress takes strong conviction and incredible will, even for those who have struggled to accept Queer, Transgender, Two-Spirit people. Canada is a progressive country; it provided protection under law since July 20, 2005 for Same-Sex



marriage. Since then the sky has not fallen, the world has not crumbled and if anything it has made the world more tolerant and accepting to the 2SLGBTQIA community. Doing the right thing is not hard if you have the will to see a better, more inclusive world.

I want to stress to Trustees you were elected to support **ALL PEOPLE**, not selecting who is granted acceptance or quoting random bible verses written thousands of years ago, trying interpreting what Jesus was or wasn't in support of. There is no way to know what Jesus meant or did not, what we know is that we are taught to accept everyone for who they are and love each other equally. I also must remind you, you are a publicly funded school system in Ontario and as such, you must abide by the Human Rights Code. The code is clear about its protection and prohibits actions to discriminate against people based on protected ground. Your work also must include breaking down systemic barriers, systemic discrimination and racism in your school system.

We strongly and unreservedly call for you to vote YES for the motion brought forward by Trustee Agnew and immediately begin the healing to the school community who have been deeply impacted by this very troubling and hurtful discussion on the merits and validity of 2SLGBTQIA+ students, staff and communities in the Catholic School System. What you do today will be remembered and you either stand on the right side of history or you risk further alienation from your community, electors and those trying to do better in our communities by breaking down barriers and building safer, more inclusive schools.

Now is the time to do the right thing, it is time for a progressive and forward thinking school system, leave the bible alone and understand how the world has changed and evolved. We do not want to go back in time, let's set the future on a path of great change and acceptance. Nobody should feel less than, unloved, not accepted or that they are living in sin.

Do what's right, Trustees, our students deserve to feel accepted and loved.

On April 20th 2021, the board of Trustees within the HCDSB met to hear delegations regarding a motion, "Supporting Our Diverse School Communities."

This motion was brought forth by Trustee Agnew that was originally proposed by a student of HCDSB. This included raising the Pride flag and providing resources and posters to students. This request was fueled by a project study they led, finding that 75.2% of their schoolmates felt unsafe.

We acknowledge that, through the student survey and through personal stories that we have heard from our own youth, that school can be a place that feels unsafe, exclusionary, and extra challenging for 2SLGBTQ+ youth. We understand that feeling unsafe and excluded can affect our mental health.

We are saddened by the actions within the HCDSB to continue to allow a rhetoric and narrative that prevents equal access to representation, resources and an affirming space for all 2SLGBTQ+ youth and families within the system. This is a human right. It is an obligation to hold these publicly funded systems accountable and support Bill C-16.

Failure to do so continues to fuel homophobia, biphobia and transphobia within these systems. Directly correlating to the marginalization, trauma and violence faced by members within our community.

Whatever the board of trustees decides, their decision will not be what determines the success of the "Supporting our Diverse Schools" initiative. The success comes from everyone who participated by researching, writing, advocating and/or witnessing this process.

We hope that you are so proud of yourselves for sharing your stories, we stand in solidarity with you. We know that everyone in the school environment will be affected by the decision, one way or another. The decision itself however, is not what defines you. PSN is here to support you. We admire your persistence and courage.

I am writing today to formally lend my support to raising the Pride Flag this June and every June in solidarity with our **LGBTQ2S+** HCDSB staff, students and families.

It is disappointing that in 2021it is necessary for a ratepayer and parent to write their school board asking elected officials to recognize the importance of ensuring all individuals be treated equally and fairly. It saddens me that a Board built on value-based learning is reluctant, at times defiant, in providing a welcoming, safe and loving space for **LGBTQ2S+** staff, students and families.

Mostly, I am disappointed in myself for choosing a Catholic education for my children that discriminates against some of our most vulnerable children. In our family, we have two golden rules:

- 1. There's always space for one more at the table
- 2. Treat others how you want to be treated

In its simplest form, raising the Pride Flag reminds the HCDSB community, and my own children, that there is always room, that we are equal. More importantly, the flag celebrates diversity, that God loves all of us exactly the way we are and that HCDSB is a safe and welcoming space for our **LGBTQ2S+** staff, students and families.
